MICHIGAN HOSPITAL FINANCES: FISCAL YEARS 1998-2002

In Brief

- Michigan hospitals taken together showed revenues from all sources exceeding expenses resulting in surpluses of \$863.1 million in 1998, \$635.4 million in 2000, \$270.1 million in 2001 and \$169.7 million in 2002 and surplus as a percent of net patient revenue dropped from 6.3 percent to 1.1 percent. Of the 149 hospitals covered in this report, 65 showed a surplus in net income from patient care in 1998 compared with 45 in 2000, 51 in 2001 and 65 in 2002.
- Losses from net patient services income dropped from a high of \$821.8 million in 2000 to \$484.2 million in 2002 while income from other than patient services such as investment and contributions fell from a 2000 high of nearly \$1.5 billion to \$654.0 million in 2002.
- By and large, reimbursements for inpatient and outpatient care do not cover the costs of providing that care as reflected in net patient revenue from services. The deficit gap increased from \$355.4 million in 1998 to \$821.8 million in 2000 before lessening to \$484.2 million in 2002.
- When non-patient services income is added, 118 of the 149 hospitals showed surpluses in 1998, 100 showed surpluses in both 2000 and 2001, and 107 did so in 2002.
- With the exception of Genesee in 2001 and 2002 and Southeast Michigan in 2002, all health systems areas (see Map 1 on page 15) experienced overall surpluses in each year in the aggregate.
- The City of Detroit health sub-area of the Southeast area, showed deficits each year \$18.2 million in 1998, \$55.9 million in 2000, \$47.5 million in 2001, and \$71.4 million in 2002.

Summary Financial Results

Summary financial results of Michigan hospitals for fiscal years ending in 1998, 2000, 2001 and 2002 are shown in **Table 1**:

Between 1998 and 2002 hospital net patient revenues grew by \$2.0 billion (15.0%) while patient service expenses rose \$2.2 billion (15.5%). With revenue from other than patient services falling by \$564.5 over the period, the statewide overall surplus declined by

\$693.6 million between 1998 and 2002 to \$169.7 million. The 2002 surplus represents 1.1% of statewide net patient revenues.

Income from Patient Services

The majority of hospitals in Michigan are losing money caring for patients but, taken together, hospitals have shown improvement in 2002 and 2001 compared with 2000. Still 2002 losses are \$128.8 million higher than they were in 1998. In total, hospital deficits from providing patient services, both inpatient and outpatient, went from \$355.4 million in 1998 to

\$821.8 million in 2000 before decreasing to \$665.7 million in 2001 and \$484.2 million in 2002.

In 1998, 65 hospitals showed surpluses from net patient services income totaling \$197.5 million while 84 hospitals had deficits totaling \$552.9 million. In 2000, 45 hospitals showed surpluses from net patient

services income totaling \$107.3 million while 104 hospitals had deficits totaling \$929.1 million. In 2001, 51 hospitals had surpluses in net patient services income of \$114.8 million and 95 hospitals had deficits totaling \$780.6 million. For 2002, 65 hospitals showed surpluses totaling \$181.0 million and 82 had deficits totaling \$665.3 million.

About the Data

Each year hospitals participating in the Medicare and Medicaid programs file cost reports and supplemental data with the federal and state governments. These reports provide verification of past reimbursement amounts and are used by the state to set future payments for the Medicaid program. The following tables and analyses are based on information files for the years 1998, 2000, 2001 and 2002. This memorandum does not include psychiatric hospitals and reflects the closings, mergers and other organizational changes that occurred over the five years. Overall financial results for 149 hospitals are included for years 1998 and 2000 and for 147 hospitals in 2000 and 2001. Data for each year reflect results for individual hospitals fiscal years from October 1 through September 30 – the state fiscal year.

Hospital Specific Data

Surplus/Deficit results for 149 individual hospitals are shown below in **Table 2** (two hospitals reflected in 2000 amounts are not shown for 2001 and 2002 due to a closing (Mercy Hospital Detroit) and an organizational change (NextCare Hospital of Muskegon)). Hospitals are those with a unique Medicare and Medicaid identification number. In some cases, separate facility locations are included in the data of the legal entity with the unique identifier.

Data Characteristics

Hospital fiscal years end at different times (most are either December 31 or June 30) so that the impact of a particular federal or state policy change or reimbursement alteration or change in economic climate can be reflected unevenly in the data of different hospitals. Hospitals may also file amended reports and the data in this memorandum may not reflect these.

Certain hospital entities have merged, changed names and/or received new identification numbers between 1998 and 2002. In these cases, the 2002 name and identifier are used.

The data in this report are derived from cost reports that are audited for compliance to independent auditor statements.

One-time income and/or expense events occur. Reimbursement from Medicare and Medicaid are sometimes in dispute for a period of years with the final result being recorded in a single year. Large bequests are required to be recorded in their entirety in the year a hospital is given the commitment although actual receipts may be spread across future time periods. Bad debt write-offs may fluctuate from one year to the next.

While psychiatric hospitals are not included, many hospitals included do provide psychiatric services and those revenues and costs are reflected in the data.

Income from Non-patient Related Activities

The addition of income and expenses not directly related to patient care improves the overall picture. This is because many hospitals have significant income from contributions, investments and other income producing activities. Between 1998 and 2002, however, the amount of this income was reduced significantly (by 46% between 1998 and 2002) and

more than offset the reduced losses in net patient revenue. The result is that overall hospital surpluses went from \$863.1 in 1998 to \$169.7 in 2002. The combination of "Net Income from Services to Patients" and "Total Other Income and Expense" results in the overall surplus or deficit for each hospital in **Table 3**.

First, hospital systems often contain entities in addition to hospitals. These may include a corporate office, non-hospital medical organizations and other units. The financial results

for these are included in the financial statements of the systems. Second, hospital systems may include adjustments made after the "Excess of (expenses over revenue) revenue over expense" line on the Consolidating Statement of Operations. Examples of these include a change in liability caused by a new calculation for minimum pension liability and changes in

the unrealized gain or loss in the fair market value of investments for the system. These may be included in an "Other Changes in Assets" section. The cost report data in this memorandum is based on the financial result for each hospital reflected as "Excess of (expenses over revenue) revenue over expenses" and before "Other Changes in Assets".

Definitions

Cost reports and supplemental data are reviewed by the state to assure agreement with the financial statements for each institution as stated by the hospital's independent auditor. Definitions are consistent with generally accepted accounting principles (GAAP). At a summary level they are:

Inpatient Income. The total amount received or carried as accounts receivable as a result of billings (charges) for services related to the provision of inpatient care during the fiscal year. Among items included are room and meals, operating room, laboratory tests, medical supplies, drugs, and the like.

Outpatient Income. This is the same as above but for outpatient care including outpatient surgery.

Contractual Allowances and Discounts. Hospitals agree to accept payment amounts that are less than charges from some third party payers such as Blue Cross/Blue Shield, Medicare, Medicaid, managed care organizations and private insurance companies. When done as a result of a formal contract or agreement the amounts are recorded as a contractual allowance. Other billings for less than usual and customary charges are recorded as discounts.

Net Patient Revenue. The sum of inpatient and outpatient revenue less contractual allowances and discounts.

Total Operating Expenses. The total of expenses recorded in pro-

viding care for both inpatient and outpatient services.

All Other Expenses. The costs of all expenses not related to patient care are recorded in this category and include such things as parking, gift shop and cafeteria, fund raising and investment management.

All Other Income. Income for the categories included in other expenses. During the 1998-2000 period investment income was an important component of the overall positive results.

Surplus/Deficit. Virtually all Michigan hospitals are not-for-profit organizations and year-end financial results are classified as a surplus or deficit rather than a profit or loss.

Health Systems Planning Areas

In the late 1960s, the state designated 8 health systems planning areas (See **Map 1**). **Table 5** reflects financial data

for these areas with the City of Detroit separated from the southeast area. In 2001 and 2002, the City of De-


troit and the Genesee area experienced an overall deficit, while only the City of Detroit did so in 1998 and 2000.

Summary

During the five years from 1998 to 2002, Michigan hospitals in total experienced a steady decline in financial status resulting from growing contractual allowances and discounts, operating expenses which grew faster than net patient revenues, and the effects of a weakened economy on investment and contributory income.

While surpluses and deficits for individual Michigan hospitals varied significantly over the period, the number of hospitals with surpluses went from 118 in 1998 to 100 in both 2000 and 2001 before increasing to 107 in 2002. The total surplus of the

hospitals taken as a group, however, declined steadily between 1998 and 2002.

A \$5.6 billion (60.7%) increase in contractual allowances and discounts between 1998 and 2002 largely offset the \$7.6 billion (33.5%) gain in patient revenue charges before these allowances. The increase in contractual allowances and discounts resulted from an increasing difference between Medicare and Medicaid rates and hospital charges and the discounts negotiated by third party insurance companies and managed care organizations. Further, the \$2.2 billion in-

crease in expenses was more than the \$2.0 billion increase in net patient revenue. This combination resulted in a \$128.8 million decrease in net revenue from patient services. When combined with the \$564.5 million reduction in income from non-patient sources, the overall change in surplus from \$863.1 million to \$169.7 million results.

The lowered revenue from sources other than patient care was chiefly caused by the reduced income from investments and contributions experienced by many institutions during the recent economic decline.
